- 1. The applicant must be at least 21 years of age.
- 2. The applicant shall not have a record of arrest and conviction in the last 10 years.
- 3. The applicant must posses a valid driver license.
- 4. The applicant must meet all firefighter training requirements set forth in the job description.
- 5. The applicant must be in good health and capable of carrying out the firefighting tasks as outlined in the job description and company handbook.

Only applicants who meet all the above criteria will be considered for employment in the Neshannock Township Volunteer Fire Company.

Any applicant given a conditional offer of employment must successfully complete the company medical examination, physical fitness for duty examination, drug screening, and background check within the timeframe allotted before a final offer of employment may be given. There is no cost to the applicant for these examinations or screenings.
